1. What is distriBind?

2. What problems does it solve and how?

By automating the exchange of data between carriers and their distributors and implementing automated real-time validation, distriBind removes the majority of low-value middle/back-office tasks from users while also delivering increased data visibility. This gives users the time and space to focus on higher-value tasks.
